IMMIGRATION UPDATES AND REMINDERS

Proposed Rule Change

On August 28, the Department of Homeland Security proposed rule changes [for F and J students and scholars](#). Currently, those in F or J status are admitted to the U.S. for “duration of status,” meaning they may remain in the country as long as they continue to meet the requirements of their academic or exchange program. The proposed rule would replace this with fixed end dates of admission. Other changes are also included in the proposed rule, including shortening the F-1 grace period at the end of a program to 30 days. At this stage, the rule is only a proposal. No changes have taken effect, and the current regulations remain in place. ISS will continue to monitor developments and share updates with you.

On September 5, 2025, the Department of State [updated instructions for all non-immigrants applying for visas](#), stating that applicants should apply at their home country embassy/consulate. Individuals from countries that do not have a U.S. embassy or consulate should apply in [designated locations](#).

Full Time Course Load

If you have not yet registered for the Fall quarter, please remember that you need to be enrolled in full time units (12 units) per your F-1/J-1 status.

Online Classes

F-1 students: only one online course can count towards your full time enrollment requirement of 12 units.

J-1 students: you can only take one online course.

If you are an Undergraduate student, this is your last quarter, and you require less than 12 units to complete your academic program, you must submit a [Reduced Course Load Form](#) to our office by 10:00 a.m. on Wednesday, October 8th, 2025. This will give us time to initiate a reduced tuition fee request on your behalf in My Forms.

F-2 students cannot be enrolled in a full course load per regulations and therefore need to be enrolled in under 12 units.

Program Extension

Don't forget to check your I-20/DS-2019 end date. If you need more time to complete your degree, you need to [apply for a program extension before your current I-20 or DS-2019 form expires](#).

Maintaining F and J status

It is very important to follow the regulations. Take the time to review information on maintaining your [F and J status](#).

If you will be working on campus in the Fall and need an [SSN](#), take the time now to complete the required [SSN letter](#). Thinking about an internship this Fall quarter? Please review our [employment information](#) for [F-1](#) and [J-1 students](#). As an F or J student, please remember that you cannot work off campus without authorization.
